

## Right of Way Grantor Farm Tap Request

This form is to be used by Northern Natural Gas Company (Northern) or gas utilities presently transporting natural gas under an existing contract or service agreement to establish a new farm tap on Northern's pipeline to provide service to a right of way grantor, or to request the revision or removal of an existing farm tap. Use of this form is limited to requests related to farm taps only.

### Instructions and Procedures

- General** - This original form, along with required attachments are always to be forwarded. Copies should be retained by each forwarding unit. The gas utility initiates the request and is responsible for procuring execution of the appropriate statement of the applicant, copies of the pipeline easement document with tap clause and the warranty deed(s).
- Section I** - The customer is to complete Section I and forward to the gas utility. In the event of a removal, the initiator of the removal completes Section I.
- Section II** - The gas utility completes Section II and forwards this form (by U.S. mail, email, or fax) with required attachments to the appropriate Northern marketer. If mailing, address to Northern Natural Gas, 1111 South 103<sup>rd</sup> Street, Omaha, NE 68124. For email address, please contact the appropriate marketing representative. If faxing, the number is 402/398-7413.
- Section III** - The Northern marketer will solicit information from the appropriate Northern operating team for completion of Section III.
- Section IV** - Northern's regional management approves in Section IV and forwards with attachments, to Northern's marketer for processing.

    Removal - **A**) Except when removal is initiated by Northern for no flow in prior twelve (12) months, initiator of removal must sign and attach a 5057Q form "Customer Consent to Remove Facility." **B**) Gas utility completes, the "Date Gas Last Flowed" information, signs, and dates. **Both A and B are required for farm tap removal.**

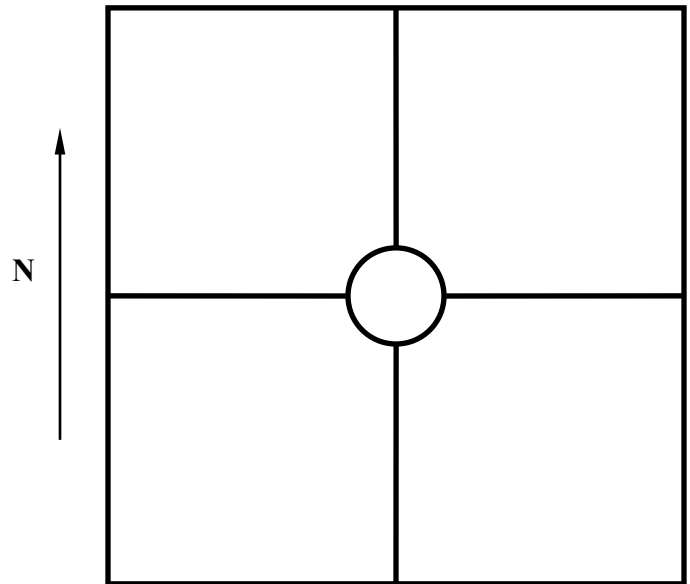

**Required for all requests for a new tap**

I understand and agree that the quality of the gas to be provided through the requested tap will be that which exists in the pipeline at the tap location and that Northern does not warrant its fitness for any particular purpose; also, that Northern does not guarantee any minimum level of delivery pressure to the Applicant at the pipeline tap. I will be the only consumer of gas delivered through this new facility.

I understand that the above information, and other information contained on this Form 1740A is required for a filing which Northern must make with the Federal Energy Regulatory Commission and that this Commission must authorize Northern to install the requested tap.
