Northern Natural Gas Company (Northern) hereby submits for filing with the Federal Energy Regulatory Commission in the above-referenced docket the following information.

During the negotiation process, Northern discusses project concerns with affected landowners and how Northern can address those concerns. Northern advises the landowners that if, at any time, they feel there are any disruptions they are uncomfortable with that they can reach out to Northern for assistance. If construction activities result in excessive or disruptive noise which makes them uncomfortable, Northern can assist with alternative accommodations if necessary. Northern reminds the landowners that we are aware each person has different needs and accommodation requests and that Northern will work with them at any time. Northern wants the landowners to know that we are committed to ensuring our project is as least impactful as possible.

Attached is a copy of the Project Information and Contact sheet that Northern will be providing to the affected landowners at least ten days prior to the start of construction. A copy of Northern's Environmental Complaint Resolution Procedures also will be provided to the landowners.

If you need to seek alternative housing during times when the planned project noise may become disruptive, Northern will reimburse you as an affected landowner for reasonable hotel or housing costs. As an alternative, if you wish not to relocate during this time period, please contact **Steven Martinez** to discuss compensation options.
