Good Morning -

Apologies for the delay in responding.

County highways within the target area (townsite of Angelo) is limited to short segments of CTH Q and Old Highway 21. The Highway Department has no immediate plans for any significant work on those highways over the next two years.

The local streets and roads in the target area are under the jurisdiction of the Town of Angelo. I am not aware of any significant work planned for those streets, but will ask the town to comment further. Jim / Norb - please review and advise Katie by return e-mail if the town has any projects planned in the target area.

The Wisconsin DOT has a resurfacing (removal and replacement) project, with related incidentals, on STH 21 between Sparta and Tomah currently scheduled for construction in 2025.
