

Market Area Group Allocation Overview

Northern Natural Gas' highest priority is to provide reliable primary firm transportation service for its shippers. Northern does not allocate primary firm receipt to primary firm delivery nominations except in a force majeure or curtailment event. Northern also provides flexibility to shippers by providing alternate firm and interruptible capacity to serve their markets. Northern endeavors to schedule or flow the shippers' nominated volumes using alternate firm and interruptible capacity to the extent of its operational capabilities. As shippers utilize this flexibility, there may be instances when it is necessary for Northern to perform capacity allocations at a group level when the nominated transportation activity exceeds the available physical pipeline capacity entering or exiting a defined group of points. This can occur because of high utilization of alternate firm or interruptible points due to supply or market pricing dynamics, planned service outages or a force majeure event.

In addition to group level allocations, Northern separately may need to allocate specific receipt or delivery points. This can occur if customers nominate alternate firm and interruptible capacity in addition to primary firm capacity at a specific point(s), resulting in nominations exceeding Northern's physical capacity. During a point allocation, only the shippers' nomination type (primary, alternate or interruptible) at the point is considered (e.g., during a receipt point allocation only the nominated receipts are reviewed for priority without consideration to the downstream path or delivery point associated with that nomination). This document only addresses allocation processes associated with group constraints.

Market Area Groups

To minimize the impact of an allocation so that only the smallest area is affected, Northern has developed 37 Market Area allocation groups. A complete list of receipt and delivery points within each allocation group can be found on Northern's website under Allocation of Capacity">Support->Allocation of Capacity Overview->Market Area Group Point Lookup. A listing of the receipt points impacted and not impacted by each Market Area group allocation, along with a map outlining each defined group, is provided in the Market Area Maps section of this document.

Whenever possible, Northern will provide advance notice of potential group allocations. As conditions develop and the potential for an allocation increases, Northern will post a non-critical notice notifying shippers of the potential allocation(s). Conditions may change unexpectedly resulting in Northern being unable to post a notice, but whenever possible, Northern will provide information of changing operational conditions on the pipeline. Notifications will not be provided for allocations that occur routinely or are commonplace, such as at certain receipt point locations in the Market Area. Customers can monitor the Informational Postings on Northern's website, or can utilize the Notification and Security Administration System and elect to have notices sent via email.


At the end of each nomination cycle, Northern posts the capacity available at receipt and delivery points, as well as for allocation groups. Shippers can access this information on Northern's Operationally Available Capacity web page.


Market Area Group Allocation Types

Market Area group allocations can occur as either a receipt group or a delivery group allocation. Nominated activity between receipt and delivery points that are located "within the group" are excluded from group allocation consideration as those nominations are not impacting the capacity from or to the constrained group.

A Market Area receipt group allocation will occur when the nominations at the receipt locations of a defined group, adjusted for counter-flow activity, exceed the pipeline capacity available to move the gas out of the defined group of points. For example, as shown in the receipt group allocation diagram to the right, a Market Area receipt group having capacity of 30 Dth/day may be allocated when the net nominated receipts of 50 Dth/day at locations within the group are greater than the pipeline capacity of 30 Dth/day available for the gas exiting the group to be delivered to locations outside of the group. This would result in 20 Dth/day of receipts being allocated and 130 Dth/day of total receipt being scheduled.

Conversely, a Market Area delivery group allocation will occur when the nominations at the delivery locations of a defined group, adjusted for counter-flow activity, exceed the pipeline capacity available to move the gas into the defined group of points. For example, as shown in the delivery group allocation diagram to the right, a Market Area delivery group having capacity of 30 Dth/day would be allocated when the net nominated deliveries of 50 Dth/day at locations within the group are greater than the pipeline capacity of 30 Dth/day available for the gas entering the group for delivery to locations within the group. This would result in 20 Dth/day of deliveries being allocated and 130 Dth/day of total deliveries being scheduled.





Standard Group Allocation Methodology

The scheduling priorities in a market group allocation take into account receipt and/or delivery nominations at locations relative to the contracted points. That is, as stated above, nominations utilizing the primary firm receipt and primary firm delivery have the highest scheduling priority. Northern does not allocate this nomination type except in a force majeure or curtailment event. Nominated counter-flow activity is considered in the allocation process and may result in scheduling activity greater than operationally available capacity.

Should Northern find it necessary to allocate a receipt group and such an allocation impacts nominations that contain primary firm receipt capacity, the primary firm receipts nominated to alternate firm deliveries will be allocated (pro rata) before allocating any primary firm receipt to primary firm delivery.

Similarly, in a delivery group allocation, the alternate firm receipts to primary firm delivery point will be allocated (pro rata) before allocating any primary firm receipt to primary firm delivery nominations.

The allocation of capacity to alternate firm nominations will be done on a pro rata basis. Group capacity will be allocated based on the priority of service shown below in a receipt or delivery group allocation. The allocation of capacity to interruptible transportation will be based on price and will be allocated prior to impacting alternate firm capacity.


ALLOCATION PRIORITY - MARKET AREA DELIVERY GROUP

Treatment of pooling nominations

Pooling allows for the aggregation of supply from various receipt locations to a single theoretical point for re-delivery to multiple markets. MID Pooling Service (MPS) contracts are required for pooling and the nomination activity on MPS contracts is not threaded or tracked from the receipt point to the delivery point. Each Market Area receipt point is eligible for pooling on MPS agreements to the MID 17 pool. Since the receipt location upstream of the pool cannot be directly tracked to the transportation deliveries sourced from the MID 17 pool, the MID 17 pool is deemed to be upstream of all Market Area delivery groups. The Ventura pool is another Market Area pool which allows the aggregation of supplies from the NBPL/NNG Ventura interconnect as an alternative to the MID 17 pool. The Ventura pool point is located within the Beatrice North, Palmyra East, Oakland and Ogden North delivery groups and upstream of all other delivery groups.

In a Market Area receipt group allocation, Northern does not allocate the receipt quantities on MPS agreements but does allocate the transportation contracts associated with the MPS nomination from a receipt point to the pool. When an MPS or pooling agreement is used at a receipt location that is part of a receipt group allocation, the receipt nomination is tracked through the pool(s) to identify the service priority (interruptible, alternate or primary firm) of the transportation contract that ultimately transports these receipts away from the pool. If associated transportation nomination has unused primary receipt capacity at the allocated receipt point, the quantities nominated at the receipt point will be considered primary firm in the allocation priority.

If a contract does not have any unused primary firm receipt capacity at the allocated receipt location, the quantities will be treated as alternate firm in the allocation priority.



Storage Usage

For each Market Area allocation group, a matrix that illustrates the impact to transportation activity and Storage Balancing Service (SBS) when a Market Area group allocation occurs is provided in the Market Area Maps section of this document. Nominations to and from storage on FDD, IDD and PDD injections and withdrawals during a Market Area group allocation are illustrated as "Not Impacted" or "Impacted". The availability of SBS during a Market Area group allocation is denoted as "SBS Enabled" or "SBS Disabled."


