A. Affiant is authorized to execute this Affidavit on behalf of \_\_\_\_\_ (Claimant).

B. Affiant herein represents to Northern Natural Gas Company (Northern) that:

Claimant has the right to process the gas tendered to Northern pursuant to the service agreements listed on Exhibit "A" which is attached hereto and from points upstream of processing plants for the removal of liquids and liquefiable hydrocarbons and that Claimant (initial in the appropriate space, line 1.1, 1.2, 1.3 or 1.4):

1.1 Deliveries Off System or to Processing Plant:

Desires to nominate volumes pursuant to the service agreements from points upstream of processing plants to delivery points upstream of a processing plant for delivery off Northern's system including to a processing plant. Claimant warrants that all volumes nominated for transportation off system including to the processing plant pursuant to the service agreements shall be volumes for which Claimant has the processing rights.

1.2 Strangers Gas:

Does not have a processing arrangement to have the volumes from points upstream of processing plants processed for the removal of liquids and liquefiable hydrocarbons and wishes to utilize the strangers gas provisions of Northern's Tariff to receive revenues from the processing of strangers gas on Northern's system. Claimant warrants that all volumes nominated from points upstream of processing plants pursuant to the service agreements shall be volumes for which Claimant has the processing rights.

1.3 Agency Agreement:

Is the shipper under the service agreement(s) listed on Exhibit "A" and appoints \_\_\_\_\_ (Designee) as its designee for the purpose of exercising the right to process the gas tendered to Northern pursuant to the service agreements from points upstream of processing plants for delivery to a processing plant for the removal of liquids and liquefiable hydrocarbons and that all volumes nominated to Northern for transportation to the plant pursuant to the service agreements shall be volumes for which Designee has the processing rights. (Attached Designee Affidavit.) Claimant warrants that all volumes nominated for

transportation off system including to the processing plant pursuant to the service agreements shall be volumes for which Claimant has the processing rights.

C. In the event Claimant's (or Designee's) right to process the gas from any of the points upstream of processing plants from which Claimant nominates terminates for any reason, Claimant shall immediately notify Northern in writing of such termination.

D. THIS AFFIDAVIT SHALL BE GOVERNED AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEBRASKA WITHOUT REGARD TO CONFLICT OF LAWS PROVISIONS.

E. Claimant shall indemnify Northern and release it from all suits, actions, claims, debts, liabilities, accounts, damages, costs, losses and expenses (including attorneys fees and court costs) arising out of the adverse claim of any person or persons disputing the claimant's interest in the processing rights or any rights to the revenues derived from the sale of any liquids or liquefiable hydrocarbons associated therewith.
