



## Carlton Resolution Group Assignment Form

Northern's Tariff, Sheet No. 263, allows a Shipper that is a Carlton Sourcer ("Assignor") to assign its rights and sourcing obligation to another Shipper ("Assignee"). To enable assignment between a group of Shippers and among Shippers with a common agent, this Carlton Resolution Assignment Form must be completed in its entirety and electronically submitted to Northern at [NNGContracts@nngco.com](mailto:NNGContracts@nngco.com) no later than two (2) workdays before any such assignment takes effect.

For assignments between entities, the entities collectively must have primary firm capacity at Carlton (or any of the other accepted receipt points) to cover the sourcing obligations.

For assignments among Shippers with a common agent, the Shippers collectively must have primary firm capacity at Carlton (or any of the other accepted receipt points) to cover the sourcing obligations of the Shippers in the agent's group.

The Assignee, or its agent, will nominate and source the gas required to comply with any Carlton Flow Order during the assignment period.

Any Shipper that has submitted a signed Carlton Resolution Group Assignment Form, will be considered an Assignee.

Assignor represents and warrants that the signatory below is duly authorized to act on and bind the respective party. By signing below, signatory agrees to assign its Carlton obligations, and further agrees to accept assignment of the Carlton obligations including any penalties from any Shippers identified on page 2 of this form.

The Assignor represents and warrants that the named agent is authorized to act on its behalf and to bind it for the purpose of assigning and accepting assignment of Carlton obligations between the Shippers in the common agent's group. Assignor hereby agrees to assign its Carlton obligation and accept assignment of Carlton obligations including any penalties from any of the Shippers in the agent's group identified on page 2 of this form.
